



TERMS AND CONDITIONS

1. Pricing and payment

Huellas en Costa Rica e-travel S.A. will do the best to confirm the itinerary as suggested, however, if any portion of the itinerary is unavailable due to space availability, we will offer a comparable alternative and advise you of any resulting increase or decrease in the prices. You will have the option of accepting the alternate arrangements or cancelling your itinerary without penalty.

A minimum of 25% non-refundable deposit at time of confirmation*
Final balance is due 60 days prior to arrival date.

*Deposit amount subject to change based on domestic flights included and/or peak season travel dates.

We accept all credit cards (MasterCard, Visa, American Express) and wire transfers.

2. Cancellations and refunds

Cancellations are subject to the following penalties of the full trip price:

- 25% non-refundable deposit due at the time of confirmation
- 60-46 days prior to arrival: 50% penalty
- 45-31 days prior to arrival: 75% penalty
- 30 days or less prior to arrival: 100% penalty

3. Travel documentation

A valid passport (at least 6 months beyond your travel date) is mandatory for passengers traveling to Costa Rica. It is the traveler responsibility to obtain current entry requirements for a destination. 4. Medical requirements

All travelers coming from the following countries must possess a yellow fever vaccination certificate before entry into Costa Rica:

America: Bolivia, Brazil, Colombia, Ecuador, Peru, Venezuela, French Guyana, Trinidad and Tobago.

Africa: Angola, Benin, Burkina Faso, Burundi, Cameroon, Central African Republic, Chad, Democratic Republic of the Congo, Republic of the Congo, Côte d'Ivoire, Eritrea, Ethiopia, Gabon, Gambia, Ghana, Guinea, Equatorial Guinea, Kenya, Liberia, Mali, Mauritania, Niger, Nigeria, Senegal, Sierra Leone, Somalia, Sudan, South Sudan, Sao Tomé and Príncipe, Tanzania, Togo, Uganda, and Zambia.

These visitors must provide a PCR-RT or antigen Covid-19 test with a negative result that was performed by a laboratory less than 72 hours before their entry into Costa Rica.

Furthermore, individuals from the above-mentioned places of origin over the age of 12 must have a document that makes it possible to verify that they are up-to-date on their Covid vaccination.

Travelers should obey the rules and regulations set forth by any local guide during the development of their trip since some tours/activities may have some level of risk.
